

ANNUAL ADMISSION CONTRACT

We, the undersigned parents/guardians, understand and agree to the following regarding attendance St. Thomas More School:

1. We accept the philosophy of St. Thomas More School as defined in the Parent Handbook, which basically is our belief in God and his teachings and which gives structure to our whole philosophy. Non-support of the Parent Handbook or the philosophy of St. Thomas More is considered a breach of contract and may result in dismissal from the school.

2. The school training is merely a supplement to the Catholic training received in our home. We agree to lead our children by good example to the fullness of Christian life. Sunday mass is an integral part of the school curriculum. We agree (if Catholic) to attend mass with our children. We also agree to pray with our children regularly and, most importantly, to teach them about the ways of God. We agree to attend the Sacramental preparation programs for students and parents.

3. We agree to pay all stated tuition and fees. (Parents paying on the one plan will lose their discount if payment is not made by the due date.)

4. We agree with the Tuition Program as outlined below:

TUITION AND FEES FOR THE 2009-2010 SCHOOL YEAR

REGISTRATION FEE

Per Child (K-8)

\$200.00

*Due no later than February 20, 2009 for returning families

TUITION PLAN A

For those not attending Mass, not using offertory envelopes totaling \$500 per year, and not participating in the Manna Program:

\$3,800.00 per child

TUITION PLAN B

For active and practicing Catholic families:

One child: \$3,000.00

Two children: \$5,600.00

Three or more children: \$8,200.00

“Active and practicing Catholic families” are those who attend Mass regularly and contribute at least \$10.00 weekly in the Sunday offertory (annual total of \$500.00 in offertory from May 1 to April 30). Active and practicing Catholic families also qualify for a Parish Scholarship from Sunday offertory. (approximately \$800.00 per child- as evidenced in tuition plan)

TUITION PLAN C

For active and practicing Catholic families (see Tuition Plan B) who also participate fully in our Manna Program:

One child: \$2,800.00

Two children: \$5,200.00

Three or more children: \$7,600.00

St. Thomas More Parish offers the Manna Program for those who choose to participate. It is a scholarship fund-raiser. Families who purchase at least \$2,500.00 of certificates annually (May 1 to April 30) and \$300.00 in school fundraising sales receive approximately \$200.00 in scholarship per child as a share of the program's profits.

5. We understand that St. Thomas More reserves the right to withhold any school documentation for nonpayment of debts owed to the school. Families may be requested to leave St. Thomas More if tuition is seriously delinquent.

The monthly payment plan will be offered by the Unity Catholic Federal Credit Union. (Packets are handed out in May)
