ANNUAL ADMISSIONS CONTRACT

We, the undersigned parents/guardians, understand and agree to the following regarding attendance to St. Thomas More School:

1. We accept the philosophy of St Thomas More School as defined in the Parent Handbook, which basically is our belief in God and his teachings and which gives structure to our whole philosophy. Non-support of the Parent Handbook or the philosophy of St. Thomas More is considered a breach of contract and may result in dismissal from the school.
2. The school training is merely a supplement to the Catholic training received in our home. We agree to lead our children by good example to the fullness of Christian life. Sunday mass is an integral part of the school curriculum. We agree (if Catholic) to attend mass with our children. We also agree to pray with our children regularly and, most importantly, to teach them about the ways of God. We agree to attend the Sacramental preparation programs for students and parents.
3. We agree to pay all stated tuition and fees. (Parents paying on the one plan will lose their discount if payment is not made by the due date.).
4. We agree with the Tuition Program as outlined below:

PARISHIONER TUITION PLAN

For active and practicing Catholic families who attend Mass regularly and contribute at least \$10.00 weekly in the Sunday offertory (annual total of \$500.00 in offertory from May 1 to April 30) and in school fundraising sales of \$600.00 between June 1 and May 31st (opt-out for a \$300.00 Fee).

One Child: \$2,800.00

Two Children: \$5,000.00

Three Children: \$7,500.00

5. We understand that St. Thomas More reserves the right to withhold any school documentation for nonpayment of debts owed to the school. Families may be requested to leave St. Thomas More if tuition is seriously delinquent.
