*In this agreement, "we", "us", and "our" means St. Thomas More School. "You" and "your" means the parent/guardian and student enrolled in St. Thomas More School.*

**Title:** Legal title to the property is in St. Thomas More School and shall at all times remain in the school. Your right of possession and use is limited to and conditioned upon your full and complete compliance with this Agreement and the Student Expectations for iPod Touch.

**Loss or Damage:** If the property is damaged, lost or stolen, you are responsible to report this to the administration immediately. Theft of the device must also be reported to local police authorities. If there is a second occurrence of damage, loss, theft, you are responsible for the full replacement value on the date of loss. You are also responsible for any repair/replacement costs not covered by the manufacturers warranty or insurance. If a student damages someone else's iPod Touch, they shall be responsible for replacing or repairing the broken hardware-software. Hence, students will not use someone else's iPod Touch without teacher permission.

**Repossession:** If you do not timely and fully comply with all terms of this Agreement and the Student Expectations for Pod Touch, including the timely return of the property, the school shall be entitled to declare you in default and come to your place of residence, or other location of the property, to take possession of the property.

**Terms of Agreement:** Your right to use and possess the property terminates no later than the last day of the school year, unless earlier terminated by the school or upon withdrawal from St. Thomas More School.
